**Congressional Gold Medal Enhancement Act of 2005:** The House passed H.R. 54, to amend title 31, United States Code, to provide reasonable standards for congressional gold medals, by a recorded vote of 231 ayes to 173 noes, Roll No. 13. **Pages H203–19**

Rejected the Crowley motion to recommit the bill to the Committee on Financial Services with instructions to report the bill back to the House forthwith with an amendment by a yea-and-nay vote of 187 ayes to 217 nays, Roll No. 12. **Pages H216–18**

Oxley manager's amendment (No. 1 printed in H. Rept. 109–1) that changes the effective date of the bill to the date of enactment. **Page H211**

Rejected:

Crowley amendment (No. 2 printed in H. Rept. 109–1) that increases the limit of gold medals provided for under the bill from two per calendar year to six per Congress (by a recorded vote of 189 ayes to 212 noes, Roll No. 10); and **Pages H211–12, H215**

Crowley amendment (No. 3 printed in H. Rept. 109–1) that provides for the equitable distribution of gold medals under the bill between the majority and minority parties (by a recorded vote of 182 ayes to 211 noes, Roll No. 11). **Pages H213–16**

H. Res. 42, the rule providing for consideration of the bill was agreed to by a voice vote, after agreeing to strike section 2 of the resolution. **Page H216**
