<sup>1</sup> On May 31, 2002, OMB reapportioned the two previously reported FY 2002 deferrals (D02-1 and D02-2) removing the deferral designations based on a recent analysis that determined that the funds do not meet the definition for deferrals contained P.L. 93-344. There is no programmatic effect of these actions. Therefore, as of June 1, 2002, no funds are being deferred. Pursuant to P.L. 93-344, until such time as the President transmits a special message to Congress on subsequent rescission proposals or deferrals no cumulative reports are required to be transmitted to the Congress.
